6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures	Keep unnecessary personnel away. Eliminate all sources of ignition. Methods and materials for containment and cleaning up	Eliminate all ignition sources (no smoking, flares, sparks or flames in immediate area). Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb with inert absorbent such as dry clay, sand or diatomaceous earth, commercial sorbents, or recover using pumps.
